1 New visual identity and narrative

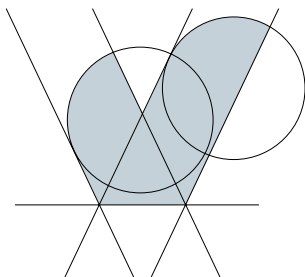
LOGO REDESIGN

NEW NARRATIVE

In 2024, VISEC consolidated its institutional narrative to reflect its commitment to sustainability and its strategic role in strengthening value chains.

- **A bridge to new markets**, promoting trade opportunities for the value chain actors.
- **A driver of Argentine leadership**, working to position the country as a global benchmark in sustainable production.



2 Engagement with the media

During 2024, VISEC's Communications team implemented a comprehensive strategy to position the platform as a national and international benchmark in traceability, sustainability and technological innovation. This strategy focused on establishing strategic links with high-profile journalists and editors, to effectively communicate VISEC's key milestones.

HIGHLIGHTS

- **Consolidated database:** creation of a journalists' network having national, provincial and international reach, with a federal approach to ensure equitable coverage.
- **Presence in specialized media:** collaborations were established with Clarín Rural, La Nación Campo, Bichos de Campo, and Agrositio, among others, for contextualized coverage of VISEC's activities both in Argentina and abroad.
- **International contacts:** engagement with regional journalists, in line with VISEC's regionalization and institutionalization strategy.
- **Key contacts with media:** meetings were held with journalists from specialized media or farming-related productions, to offer them information about VISEC and establish a personalized contact. The reference people contacted work in

We have been actively in contact with the Argentine Association of Agricultural Journalists (CAPA), strengthening collaboration with reference people in the farming sector to guarantee communication in line with VISEC's values and objectives.

RESULTS

- **100+ articles and interviews:** participation in interviews and generation of information replicated in national and international media.
- **Impact:** replication of news articles in specialized and general media, consolidating the public perception of VISEC as a reference in the sector
- **Specialized communication channels through professional associations:** in agreement with magazines and newsletters for professionals, publication of technical materials such as the RENSPA instructions. Some of the channels were used in collaboration with *Errepar* and the *Argentine Federation of Associations of Professionals in Economic Science*, among others.

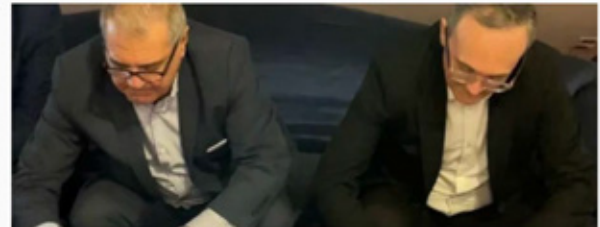

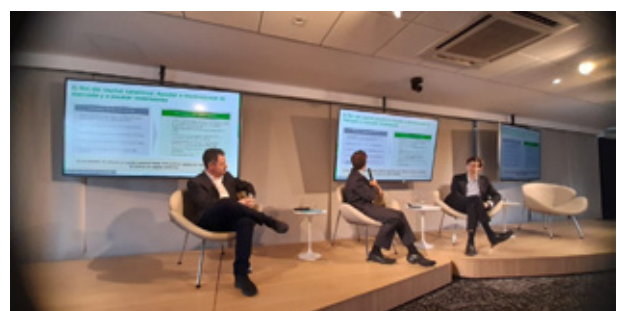

Technical Committee

The purpose of the committee is to validate the implementation of the Monitoring, Reporting and Verification (MRV) system, and the protocol that will enable traceability of soybeans, beef and by-products across the value chain.

The Technical Committee was consolidated as a key forum for the presentation and joint construction of processes in the MRV systems. With monthly meetings, it enabled a constant dialogue on regulatory news, technological developments, and progress of the system implementation.

Highlights

- **RENSPA update:** Communications relative to producers' registrations updates, facilitating their inclusion into the MRV Soybean System.
- **Technical Publications:** distribution of technical materials through newsletters, magazines and mailing systems of the aforementioned institutions.

UPDATED PROTOCOLS AND ANNEXES

In collaboration with the VISEC Secretariat and Technical Committee, two updated versions of the VISEC Protocol were drafted in Spanish and English. These versions include:

- Adjustments based on the EUDR Regulation (*European Union Deforestation Regulation*).
- Specific adaptations to the Regulation suggested by VISEC.

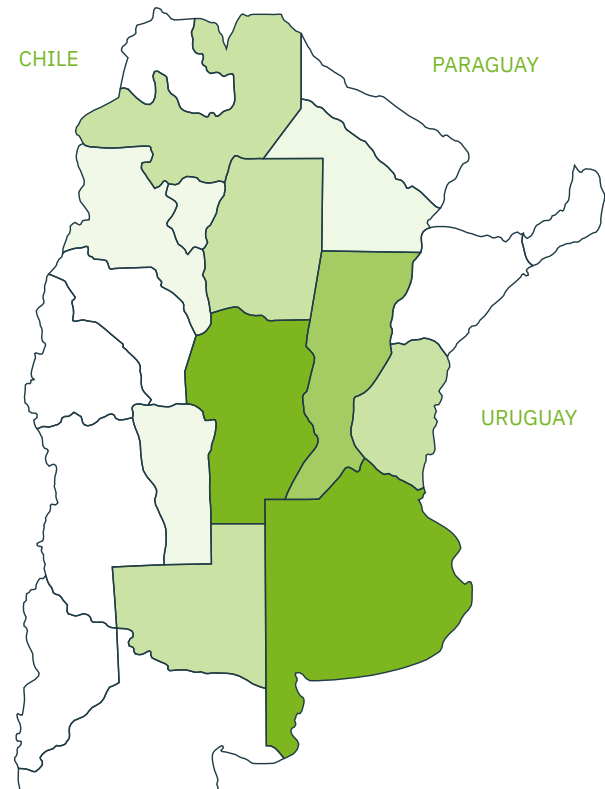
Led by the Rosario Stock Exchange, we spent 2024 working hard on the following:

- Registration of production units and data on producer companies.
- Inclusion of terms and conditions and producers' affidavit into the system.
- Conceptualization of business needs.
- Environment management and necessary infrastructure.
- Support for deliverables, demos, inductions and tests in staging (*test environment*) as well as data upload in production (*productive environment*).
- Execution of associated systems in the security test cycles
- Survey of requirements for 2025

PILOT TESTS

Three pilot tests of soybean meal shipments to the European Union were successfully carried out during 2024, totaling 56,243 tons from 321 Production Units (PU) registered with VISEC.

During the tests, VISEC supported the value chain in the challenging task of passing over this information in an efficient, traceable and confidential manner across the entire supply chain, including sending detailed information from VISEC to the European Union information system, ensuring compliance with Regulation 1115/2023.

In these tests the soybean industry has proved to have enough information and technical experience to comply with international regulations, thus laying a solid foundation for the future.

Strategic Alliances and Collaborations

DIALOGUE WITH THE NATIONAL GOVERNMENT

WISEC consolidated its relationship with the national government, achieving significant progress in the integration of systems and the positioning of the platform as a strategic tool for sustainability and traceability in international trade.

WISEC - SISA Integration:

- Streamlining export procedures through access to the AFIP's Simplified Agricultural Information System (SISA)
- Official Gazette Resolution 5533/2024.
- This integration allows WISEC to access key data to verify deforestation-free production units, avoiding duplication of records.
- The integration is carried out voluntarily and with the individual permission of producers.
- Registration with the Directory of Agroindustrial Differentiation Schemes EX-2024-114741673- -APN-SSMAIEJ#M

Collaboration Agreement with Córdoba Province

WISEC signed a collaboration agreement with the Ministry of Bioagroindustry of Córdoba Province to promote trading of deforestation-free soybeans and beef.

Collaboration with the Foreign Office and Embassies:

- Workshops in Europe to present the MRV System and consolidate the platform's international positioning.
- Official statements from the Foreign Office highlighted WISEC as a voluntary and collaborative tool, aligned with international technical standards.

ADHESION OF GRAIN BOARDS

WISEC incorporated the 7 main trade exchanges in the country: Buenos Aires, Rosario, Córdoba, Santa Fe, Bahía Blanca, Entre Ríos and Chaco.

Impact: This achievement reinforces federalism in the implementation of the MRV System, as it guarantees national reach.

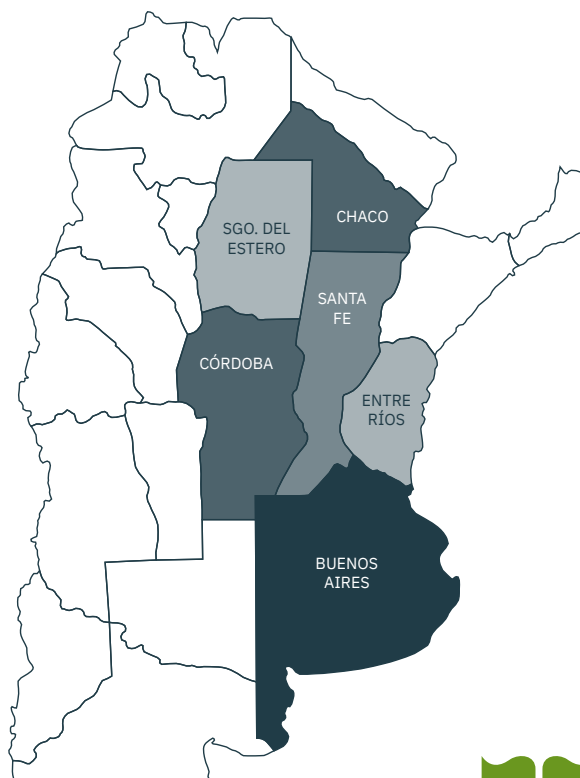

From Vision to Reality

During 2024, VISEC continued working on its institutionalization and positioning process, consolidating as a relevant platform in the agribusiness sector at the national and international level.

Recognition and legitimacy:
